PLEASE READ:

FOR THE SAFETY OF OUR CHILDREN

To prevent children from running into the street and possibly being injured we require the following:

- **DISTRIBUTIONS OF ANY KIND ARE NOT ALLOWED FROM PARADE FLOATS OR VEHICLES.**
- If you are part of a float, riding on a float or riding in a vehicle, you are **NOT ALLOWED TO DISTRIBUTE ITEMS OF ANY KIND!**

Distributions (candy, stickers, flyers, etc.) intended for parade spectators/viewers **must be handed directly to the recipient by a representative walking adjacent to your float or vehicle, along the curb side. People distributing items may NOT go near the float at any time during the parade. Those making the distributions need to carry the items they are distributing with them or have someone walking next to them to hold the items being distributed (a wagon can be pulled to hold items as well, but there absolutely can not be any type of motorized vehicle near the curb sides.**

REPEAT: IF YOU ARE DISTRIBUTING ITEMS, YOU MUST BE WALKING ADJACENT TO THE FLOAT ALONG THE CURBSIDE.

NOTE: ONLY PARADE PARTICIPANTS WHO ARE WALKING ALONG THE CURB SIDE (ADJACENT TO THEIR VEHICLE OR FLOAT) ARE ALLOWED TO DISTRIBUTE ITEMS. THOSE DISTRIBUTING ITEMS CAN NOT GO TO THE FLOAT TO RESTOCK WHAT THEY ARE DISTRIBUTING.

THIS IS TO PREVENT CHILDREN FROM RUNNING INTO THE STREET AND BEING INJURED!

ABSOLUTELY NO ITEMS ARE TO BE THROWN!

All Vehicles and Floats **MUST STAY BETWEEN THE TWO CENTER LANES OF THE STREET (on 84th Street from 6th Street all the way to Halleck Street).** No vehicle, motorcycle, float, bike, moped, scooter etc. is allowed to go outside of the center two lanes. This is for the **SAFETY** of the Parade Viewers.

PENALTY: *If the safety rules on this form are not followed; you will not be allowed to participate in the parade the following year.*

All parade entries are encouraged to decorate their float/vehicle to represent the annual theme which is “Field of Dreams” for 2011. Please contact the Papillion Community Foundation should you have questions about float décor.
